

Nautilus Productions License Agreement

BY USING ANY NAUTILUS PRODUCTIONS PRODUCT ("FOOTAGE"), IN ANY FORM WHETHER VIA VIDEO TAPE, DOWNLOAD, DVD, CD ROM OR OTHER MEDIA, YOU ("LICENSEE") AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU ARE ENTERING THIS AGREEMENT ON BEHALF OF YOUR EMPLOYER, THE LICENSE GRANTED AND RESTRICTIONS AND LIMITATIONS RECITED HEREIN APPLY TO YOUR EMPLOYER AS WELL AS TO YOU AS A REPRESENTATIVE OF YOUR EMPLOYER. SHOULD YOU CEASE WORKING FOR YOUR EMPLOYER, YOUR EMPLOYER MAY CONTINUE TO OPERATE UNDER THIS AGREEMENT.

Definitions

The Footage is any images, clips, animations, films, videos or other audio/visual representations recorded in any format that are controlled by or obtained, directly or indirectly, from Nautilus Productions.

Grant Of License

Upon use of the Footage, you are granted a non-exclusive, non-transferable license to use and modify the Footage subject within the named project subject to the following terms and conditions:

Single Use License

The Footage may only be modified or used in unmodified form, on one computer at any one time. You may not rent, lease, lend, sell or sublicense the Footage to another person, company or other entity. Anything you produce using the Footage must be for your own use, or for the use of your employer, client or customer, who must be the end-user of your work. Footage rights are worldwide, all media in perpetuity unless otherwise noted.

Non-Retail Uses

The Footage may be incorporated into a derivative work such as a film, video, broadcast, multimedia, advertisement, live performance, internet, presentation, or print project, but the Footage and any derivative work thereof may not be used, sold, licensed, recut, reproduced, distributed or displayed as stand-alone backgrounds, stock or effects imagery elements, made available as downloadable files or included in any other clip media/stock product, library, collection, or set of clips for distribution or resale. These terms apply even if the Footage has been significantly altered.

Retail Products

Copies of works (DVDs, Home Videos, Music Videos, Training Videos, etc.) incorporating the Footage may be reproduced, sold and distributed with the following limitations: The Footage may not comprise more than 25% (by length or number) of the total imagery used in the finished work, nor may the primary value of the product come from the Footage. Additionally, you agree to take all steps necessary to prevent any third party from duplicating or distributing any of the Footage included in the finished work. Please note that special licensing to obtain additional rights is available by contacting

Nautilus Productions. In addition, Nautilus Productions requests a credit line that reads "Nautilus Productions Stock Footage, Stock Footage – Nautilus Productions or Stock Footage provided by Nautilus Productions."

Marketing and Promotion

Unless Nautilus Productions receives written notification from you to the contrary, you hereby grant Nautilus Productions the right to display any derivative works within your possession or control that incorporate one or more of the Footage at tradeshows, in collateral, and/or via electronic distribution for Nautilus Productions marketing, educational, and promotional purposes as examples of customer usage. At your request, Nautilus Productions will identify you as the author of such derivative work.

Special Limitations

The Nautilus Productions footage may not under any circumstances be used in or in conjunction with pornographic, defamatory, obscene, fraudulent, libelous, infringing, immoral, or illegal material.

Nautilus Productions grants no rights and makes no warranties with regard to the use of names, trademarks, trade dress, registered, unregistered or copyrighted designs or works of art or architecture depicted in any Licensed Material, and Licensee must satisfy itself that all the necessary rights or consents regarding any of the above, as may be required for reproduction, have been obtained

Copyright

No title or intellectual property rights in the Footage is transferred to you. Nautilus Productions retains all rights not expressly granted by this license Agreement.

Liability

Nautilus Productions will not be liable to you for any special, indirect, consequential, punitive, or incidental damages (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use Footage. LICENSOR'S ENTIRE LIABILITY AND YOUR EXCLUSIVE REMEDY SHALL BE no more than the amount paid for the particular Footage. Your rights may vary from state to state.

Breach of Agreement

You agree to indemnify and hold Nautilus Productions harmless from and against any damages or liability of any kind arising from your use of the footage in any form, any breach of the terms and conditions of this Agreement, or your negligent act, omission or willful misconduct. If any part of this Agreement is found void and unenforceable, it will not affect the validity of the balance of the Agreement, which shall remain valid and enforceable according to its terms. All license rights granted pursuant to this Agreement shall automatically terminate upon your breach of this Agreement.

Warranty

Nautilus Productions warrants footage to be free from defects in material and workmanship for 90 days from delivery. Your sole and exclusive remedy for a breach of this warranty is the replacement of Footage, applicable media or a refund of the purchase price, at the option of Nautilus Productions. Nautilus Productions MAKES NO OTHER WARRANTIES OR REPRESENTATIONS WITH REGARD TO THE FOOTAGE AND ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE OR NONINFRINGEMENT ARE HEREBY DISCLAIMED.

Amendments

Nautilus Productions reserves the right to amend this agreement at any time.

Enforceability

If any part of this Agreement is found void and unenforceable, it will not affect the validity of the balance of the Agreement, which shall remain valid and enforceable according to its terms.
